

Chapter 6 PENALTIES, FEES AND FINES*

Sec. 6-1. Penalty for delinquent payment of taxes.

The director of finance of the County, shall collect a penalty at the rate of one (1) percent for each month or fraction of a month against all ordinary taxes levied by the Village when payment of ordinary taxes is not received prior to October first for the fiscal year beginning July first.

Sec. 6-2. Fees and charges for permits and services.

Sec. 6-4. Presumption that violation is a municipal infraction.

A violation of any provision of this Code is hereby specially designated to be a municipal infraction unless specifically declared to be a misdemeanor, felony, or otherwise designated, and unless otherwise specifically provided, the penalty therefore shall be a fine of twenty-five dollars (\$25.00).
