

November 2017 CCVPD Highlights

Crime/Operational

- **2 theft-from-vehicle events:**
 - **5500 block of Center Street:** On 11/15/17 at 9:10 a.m., a construction worker confronted a thief sitting in his truck; the thief and an accomplice fled; nothing taken. Suspects have been identified and charges are being pursued.
 - **5400 block of Grove Street:** On 11/28/17 at 8:50 p.m., two males riding bicycles stopped on Grove Street near the Mormon Church. One acted as a lookout while the other entered 2 unlocked cars belonging to the same resident. Nothing was taken. The crime was captured by a neighbor's security camera system.

Administrative/Training

1. Officers were trained on Maryland's new medical marijuana law and our new restrictive vehicular pursuit policy this month.
2. All officers successfully qualified with their firearms for the second time this year and they also received refresher training on our use of force policy.

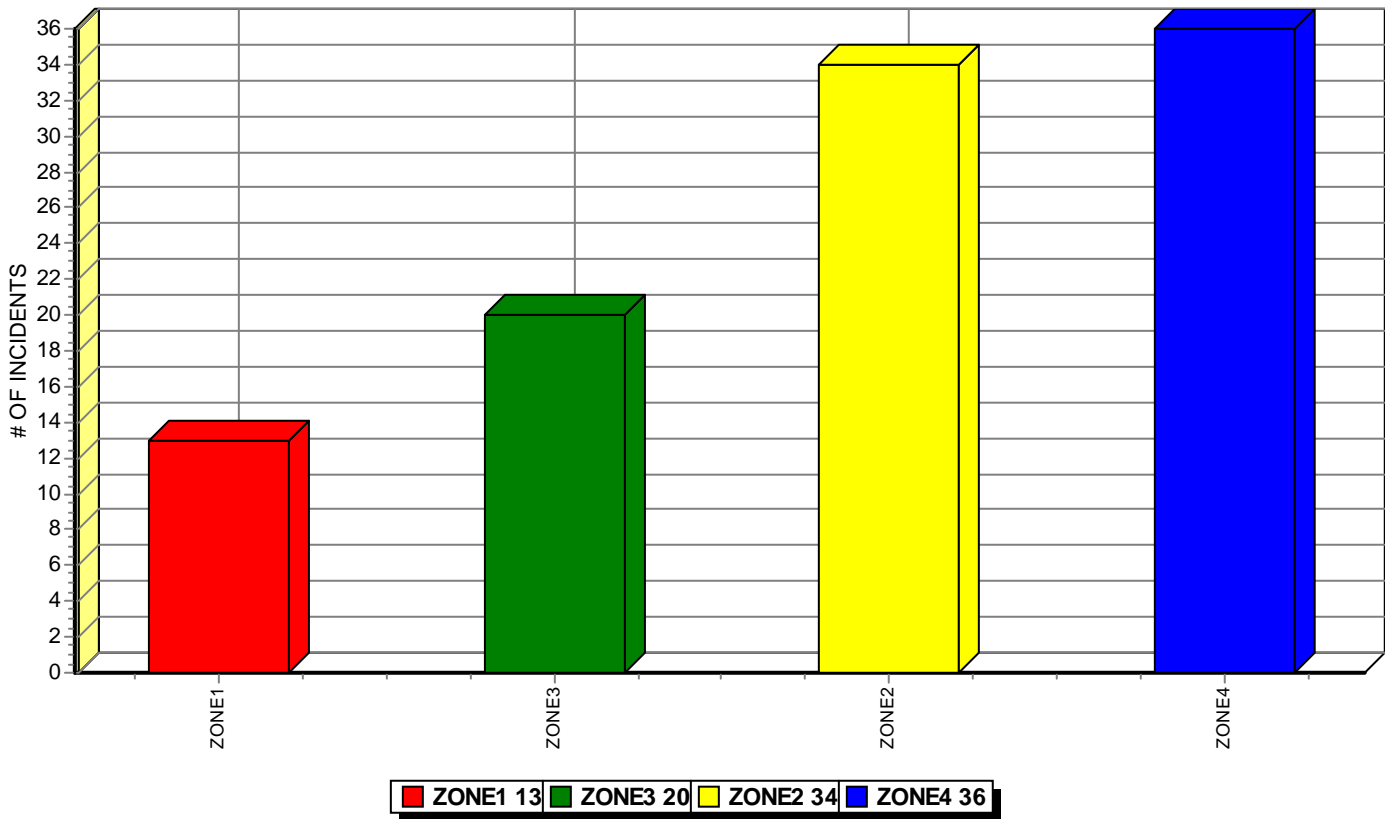

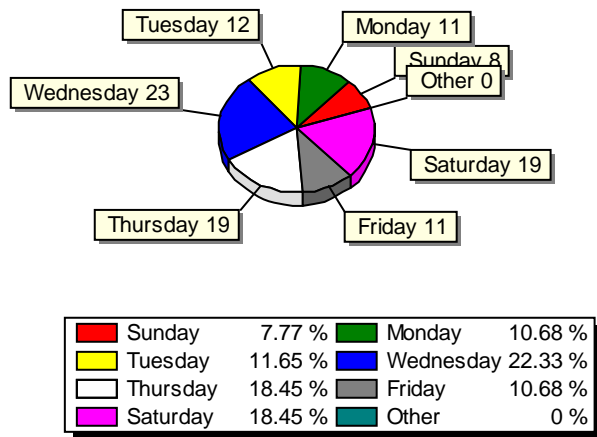

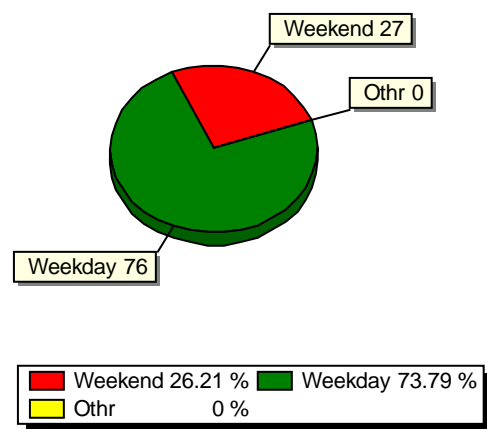
Incident Frequency by DISTRICT (Top 4 of 4 Shown) (Using DATE RECD)



By Day of Week

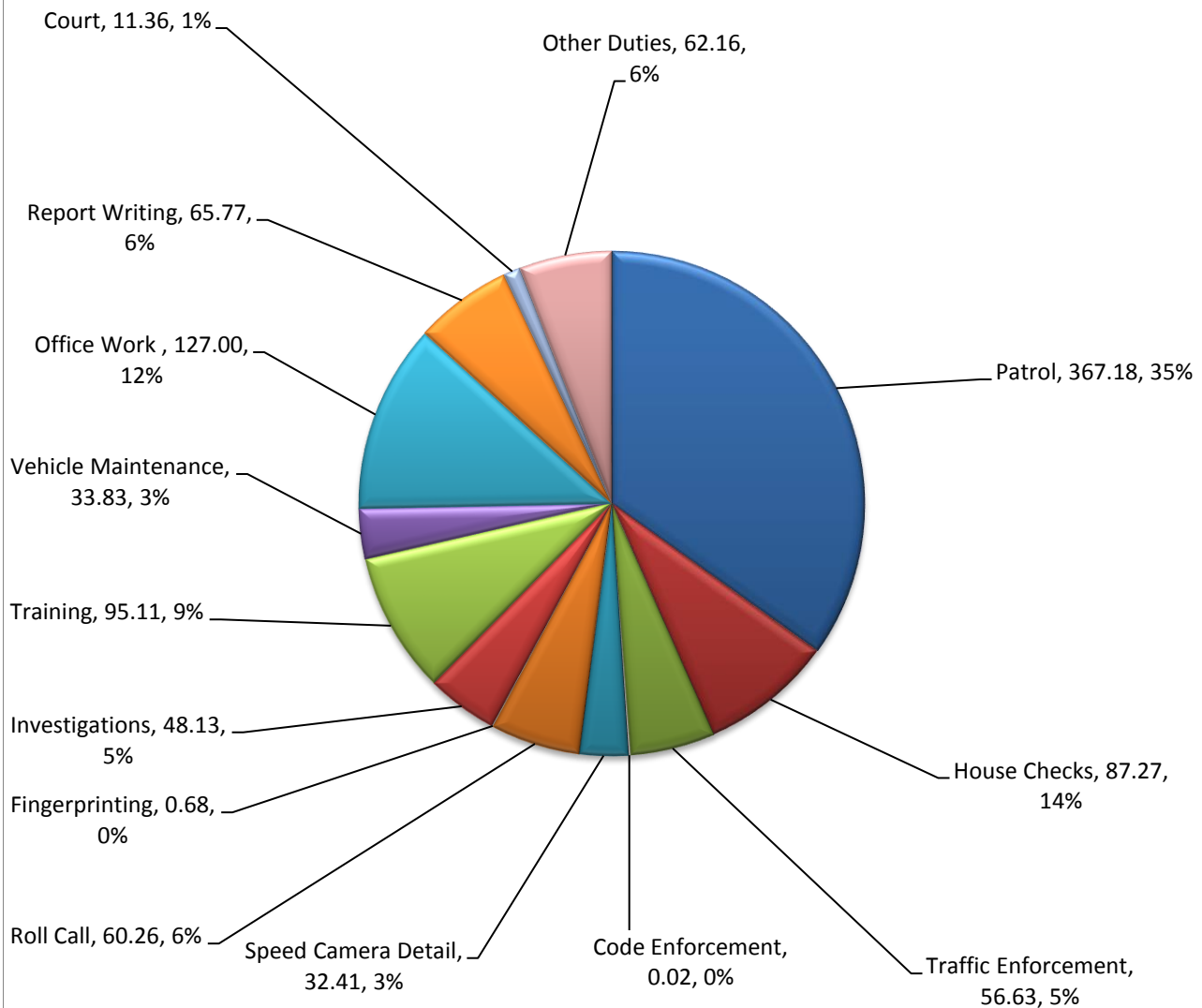


Weekday vs Weekend
