

## August 2019 CCVPD Highlights

### Crime/Operational

Four daytime thefts from cars; two were committed by breaking windows and two were unlocked:

- **Magnolia Parkway between Chevy Chase Circle and W. Irving Street:** window broken; purse, sunglasses and credit cards stolen
- **Unit block of Hesketh Street:** window broken; purse, \$2,000 cash, and personal items stolen; all items were recovered a block away except \$650 in cash.
- **6300 block of Broad Branch Road:** Unlocked work truck; check book stolen
- **5600 block Kirkside Drive:** Unlocked work truck; Apple watch and iPhone stolen

- Officer Timmerman has been on light duty (broke his wrist while off duty); we expect to have him back to full duty within the next 2 weeks.

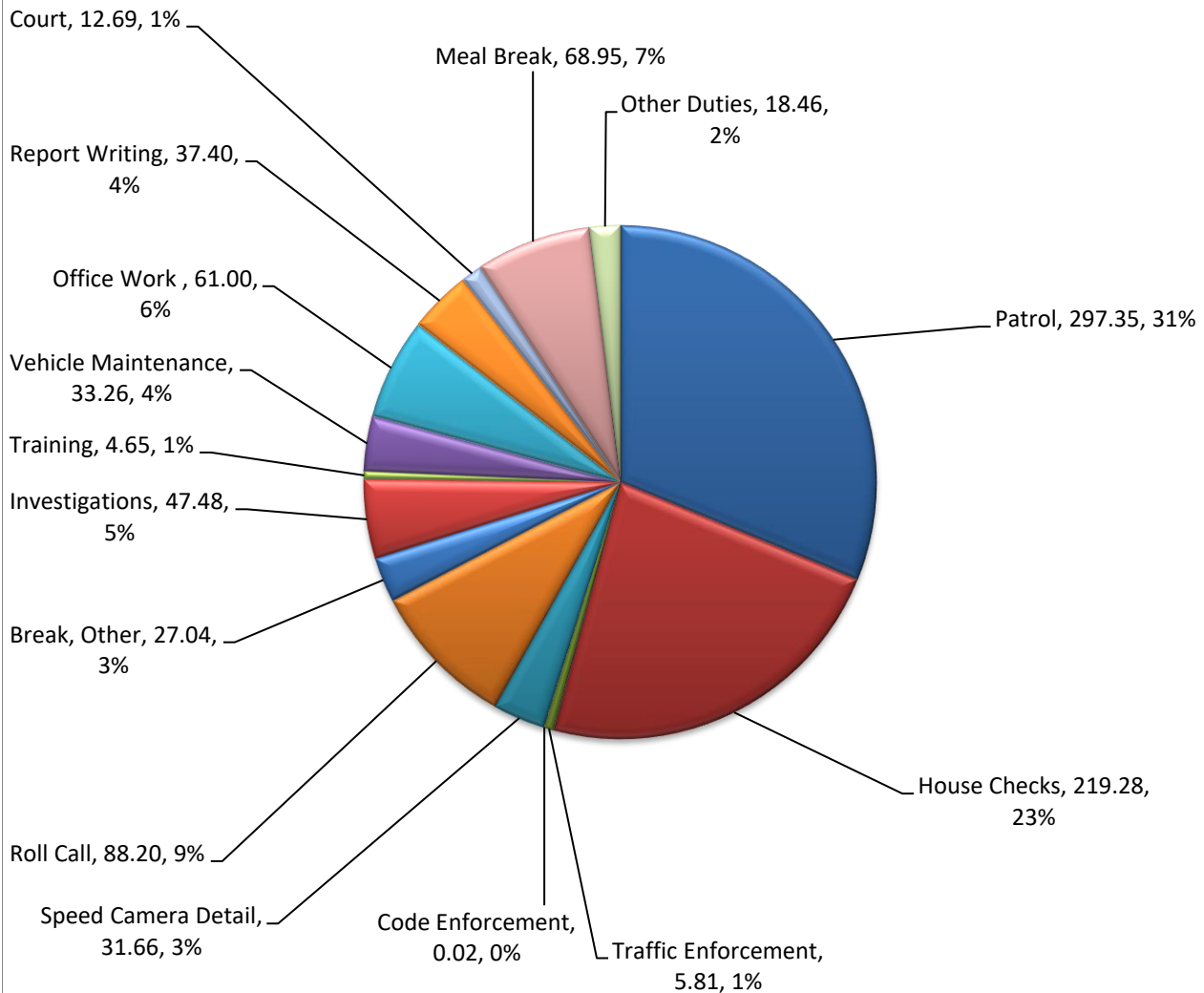

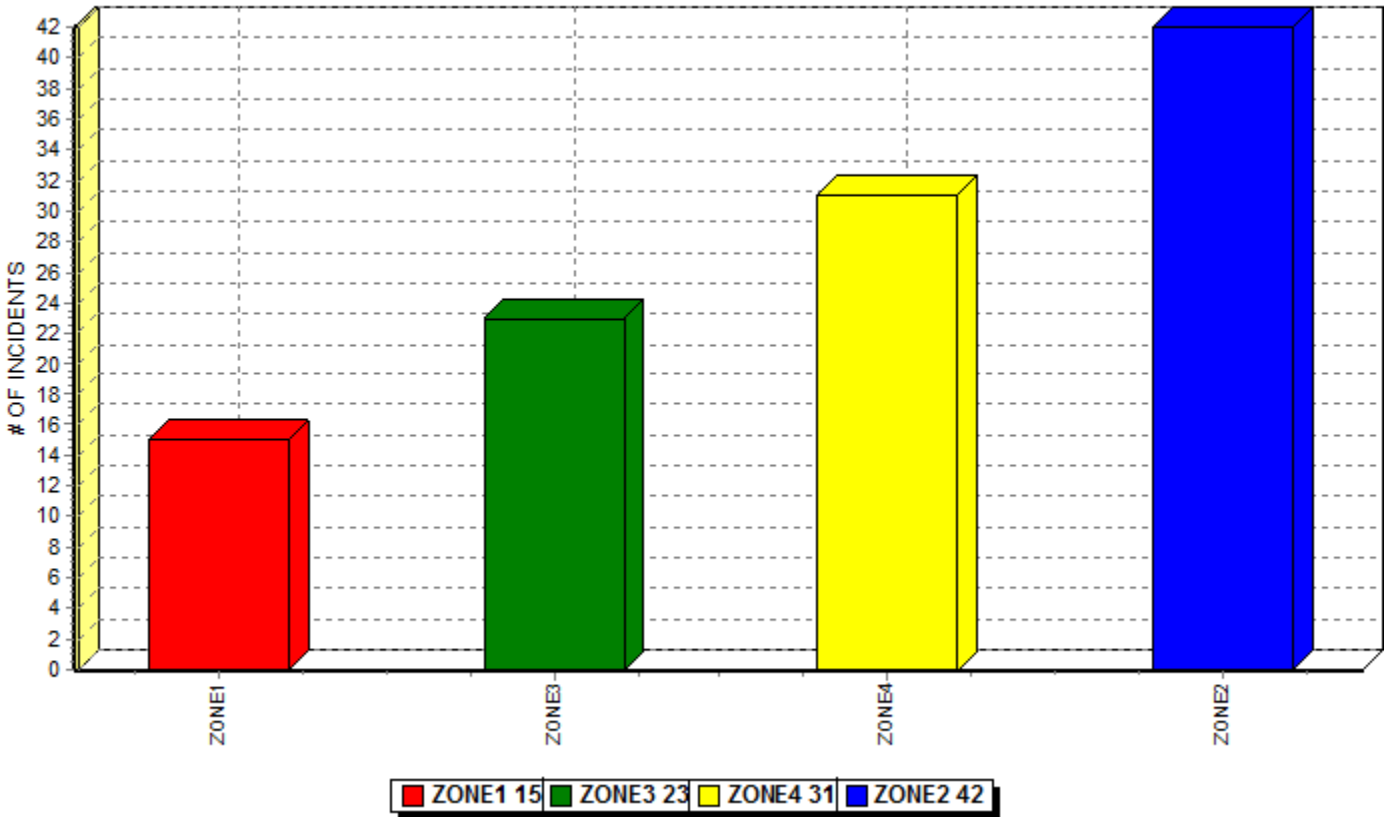

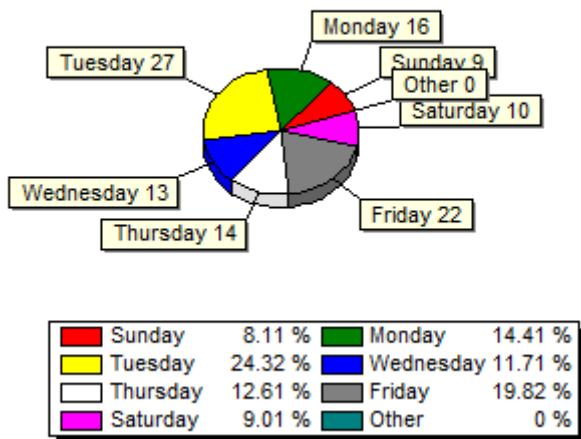

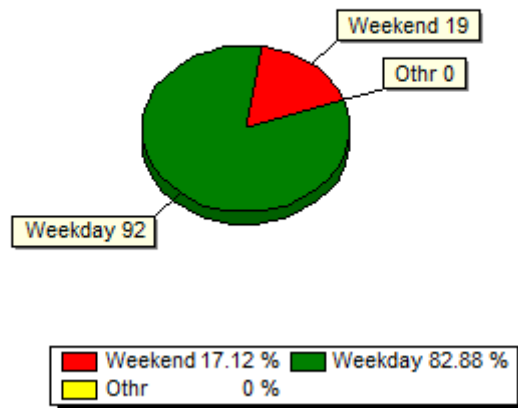
**Incident Frequency by DISTRICT (Top 4 of 4 Shown) (Using DATE RECD)**
